Best Effort Rate Sheet Restructure

Effective **Wednesday, March 27, 2024**, Pennymac will be updating the Best Effort rate sheet to include new state-specific Conventional base pricing grids. These new grids will be on distinct tabs on the rate sheet; standard Conventional LLPAs will apply. The following changes will be made:

- Adding new "FNMA State Specific" tab on the rate sheet
- Adding new "FHLMC State Specific" tab on the rate sheet
- Removing State-Specific base pricing grids from the "FNMA" and "FHLMC" tabs on the rate sheet.
