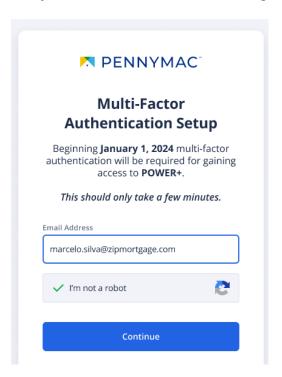
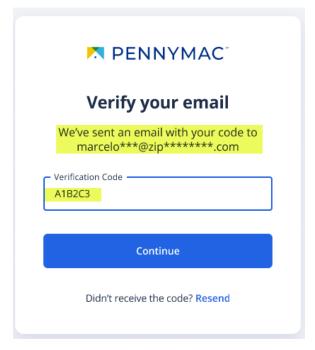


TPO and P3 Multi Factor Authentication (MFA) Registration

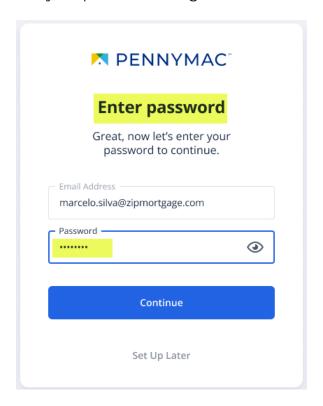
1. Enter your email to start the MFA registration / then click continue



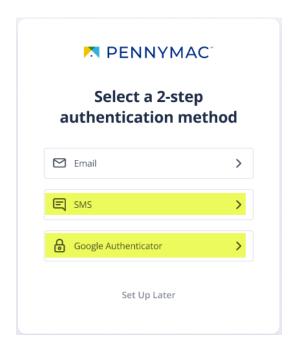
2. You will receive a verification code in your email



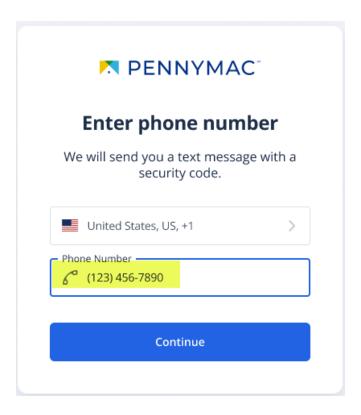
3. Enter your password to login



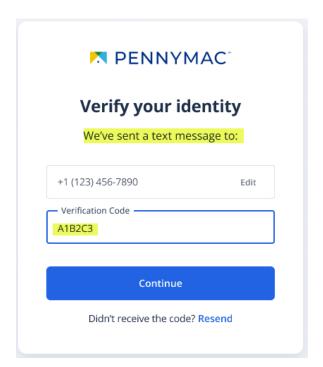
4. Select either SMS or Google Authenticator for your 2-step method



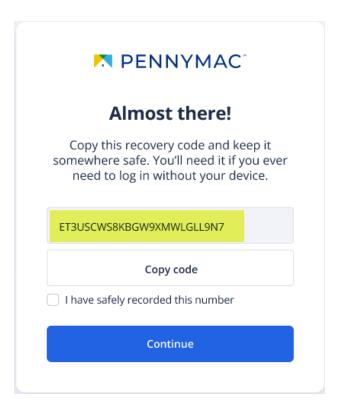
5. Enter the phone number where you will receive the verifications



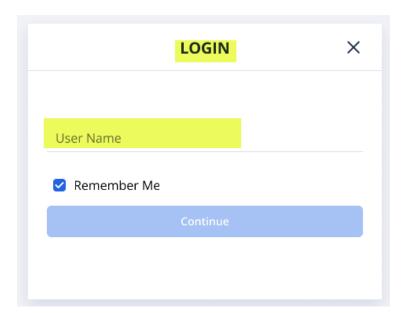
6. Enter the verification code you received via SMS

Google Chrome:

To Clear Chrome Cookies and Cache:

- 1. Make sure that you're using Chrome Internet Browser then click three dots in the upper right corner.

- 3. Make sure the time range is set to all time and make all three categories have blue check marks.
- 4. Click Clear Data. Once finished, restart the Chrome browser.

Microsoft Edge:
